Membership administration privacy policy

We take the protection of your personal data very seriously. This privacy policy provides an overview of how we process your data for the purposes of managing your membership. Detailed information about how ÖGB handles your personal data is available at www.oegpb.at/datenschutz.

The data controller responsible for the processing of your data is the Austrian Trade Union Federation (ÖGB). We will treat the information you have provided to us as strictly confidential, and will only process it for the purposes of managing your union membership and for the duration of your membership and the period of time in which claims can be made in relation to your membership. The legal basis for processing your data is your membership of ÖGB and, if you have agreed to your union fee being deducted at source, your consent to the processing of the additional data required.

Your data will only be processed by ÖGB itself or by processors under contract with and monitored by ÖGB. Your data will not be disclosed to third parties in any other way without your explicit consent. Your data will be processed exclusively in the EU.

You have the right to request access to the personal data that ÖGB is processing about you. You also have the right to request that this data be rectified or erased or that its processing be restricted. If you believe that ÖGB has been unlawfully processing your data, you may lodge a complaint with the Austrian Data Protection Authority (www.dsb.gv.at) in their role as a supervisory authority.

Deduction from my wages/salary/pension at source:
I declare that I consent to my union fee being deducted at source from my salary or wages by my employer, from my apprenticeship pay or from my pension by my pension scheme. I therefore give my consent for the personal data required in order for my fee to be collected, specifically the data provided above as well as my union membership, social insurance number, employee reference number, payment details, applicable collective agreements, date of joining/leaving the company, information about parental leave, retirement, hours worked, training periods and periods of civilian service, and any changes to my address, to be processed by my employer and the union. I may, however, withdraw my consent to the deduction of the fee at source by contacting the Austrian Trade Union Federation (ÖGB) at any time.

SEPA direct debit:
I authorise the Austrian Trade Union Federation (ÖGB) or the unions affiliated with ÖGB to collect periodic payments from my account via SEPA direct debit. I hereby also instruct my bank to pay SEPA direct debits from my account as requested by ÖGB. Subject to the terms and conditions agreed with my bank, I can demand reimbursement of the debited amount within eight weeks of the date of debiting, or if I have agreed to my union fee being deducted at source but no longer wish to pay in this way, have left the company for which I was working or it is no longer possible for my membership fee to be deducted at source, I would like to request without the need for further consultation that my method of payment be switched to SEPA direct debit using the account details provided.
